The Role of a CISO

- The CISO (Chief Information Security Officer) is the person with direct accountability for the security of the organisation's information assets
- The CISO manages governance, risk and compliance (GRC)
- The CISO ensures that risk is identified, evaluated and managed to reduce your risk exposure
- The CISO establishes a Security Programme to ensure that the necessary controls are in place that meets the needs and business objectives of the organisation
- The CISO is part of the organisations senior management team and reports directly to the board level stakeholders
- Ultimately, the CISO's role is to protect the business from the ever-increasing threat of Cyber Crime and the disastrous impact that this can have on the organisation's finances and reputation





Cyber Crime

- **50% of UK businesses** reported cyber security breaches in the past 12 month (Office for National Statistics)
- Ransomware is the most serious threat to UK business operations (National Crime Agency)
- The average ransomware payment has now risen to over **1 million dollars** (National Crime Agency)
- More legislation is being introduced to ensure that organisations reduce their risk of financial penalties
- Current legislation can result in significant fines (**4% of global turnover**) in the event of a reportable data breach (UK GDPR)
- People and not technology present the biggest risk to most organisations, they are unaware of the risk and not properly trained
- Most organisations are not prepared to defend themselves from Cyber Crime
